Our Code of Ethics

In Brief

1. I will serve the best interests of my clients. And I will conduct my professional activities without causing or intending to cause any harm.
2. I will treat all my clients with equal respect, regardless of their origin, race, religion, gender, age, or sexual preference. Fees will be discussed and agreed prior to any readings, teaching or talks taking place.
3. I will represent honestly my Tarot qualifications, including educational credentials and levels of certification. I will publish my Code of Ethics and Conduct and abide by the guidelines of the Tarot Association of the British Isles (TABI), with whom I am an Endorsed Reader & Member.
4. I will keep confidential the names of clients and all information shared or discussed during readings, unless otherwise requested by the client or required by a court of law. I will read for those who ask for readings and do not read for any third parties without their consent as I will not invade anyone's right to privacy.
5. I will recommend clients consult a licensed professional for advice of a legal, financial, medical, or psychological nature that I am not qualified to provide. If trained in one of these areas, I will clearly differentiate between the tarot reading and any professional advice additionally provided. I will ensure that my clients are aware that for legal reasons this service can only be classed as entertainment, and that I accept no responsibility for any losses for actions taken on the strength of the reading. My readings aim to empower my clients and help them take charge of their own life.
6. I will respect my clients' right to refuse or terminate their reading at any time, regardless of prior consent. My clients will respect my right to refuse or terminate a reading at any time, especially if they are under the influence of drugs or alcohol.
7. I am committed to personal and professional development for myself, my clients and fellow Tarot Consultants and enthusiasts.

In More Depth

I primarily use the Tarot as a multi-level instrument to assess and explore your personal and professional concerns. Once we have delved into all aspects of your issue we can determine potential actions and belief patterns that can serve as transformative, positive solutions. It is important that you remember that at all times you are in control and you have free will to make your own decisions. I will work with you as reader, interpreter, counsellor and coach. My goal is to empower you. You are 100% responsible for your own choices and actions. My aim is to help you see what resources you have available.

My focus is not predictive but I agree that the Tarot is an oracle as well as a tool for self-assessment and self-help. My method of reading is to concentrate on interpreting the cards, based on my years of extensive study of Tarot, Counselling, Coaching, Business, Psychology and my intuition. Any forecasting derives naturally from that point of convergence.

We're all blessed with free will and a Tarot reading is like a snapshot photograph – it provides a studio portrait of the situation and possible future trend, based on matters remaining the same as they are at the time of the reading. If you don't like the photograph, you have the power to 'edit' the picture to your personal satisfaction. Free will is exactly that, not just doing something slightly different to whatever we have done before.

Tarot is a symbolic language. Each card has multiple potential meanings, depending on the surrounding cards. The Death card (number 13) does not mean actual physical death. I translate the language of Tarot and work with you to achieve clarity and a sense of preparedness and confidence, to face whatever issues have arisen. My role is to empower those who come to me for Tarot readings, not scare you or assure you of my "powers".

I am a Tarot reader, speaker, trainer, coach and consultant, not a doctor, lawyer, or financial adviser. I recommend that you seek professional advice on any medical, legal or financial matters. I will never offer to remove a curse or perform a magic spell for money. That is not what I do as a Tarot Professional. I urge you to avoid any Tarot reader who offers these services to you. Scam artists reflect badly on legitimate, ethical Tarot readers and consultants.

REMEMBER: Just as there are bad doctors, there are bad Tarot readers. I urge you to use common sense when choosing either.

It is my pleasure and my responsibility to treat every seeker with warmth, sensitivity and compassion. I hold your Tarot reading, and any information you reveal, in the strictest confidence. I am not entitled, nor do I want, to judge your past, present and/or future actions. Any decisions that you choose to make based on the reading are your responsibility. Please do not see me as an oracle. All you need is within you. The Tarot is simply a shared visual vocabulary we can use as a tool to dig deeper and identify options and choices available to you. The Tarot is an oracle; I am the human interpreter, and as such, fallible. The Tarot cards impel. They do not compel. You are the one who holds your future in your hands.
